

SADA's status on the national level is defined by two basic documents:

- a) **Act No. 440/2015 Coll.** on Sport and on Amendments and Additions to Certain Acts, as amended (hereinafter referred to as the "Act").
- b) **SADA Statute** the Ministry of Education, Science, Research and Sport of the Slovak Republic, pursuant to Section 86(6) of Act No. 440/2015, has issued this Statute under No. 2016-9381/3493:1-56AA with effect from 1 February 2016. Under the Statute, SADA is a legal person acting in legal relations in its own name, acquires rights, undertakes obligations and has responsibilities arising from these relations.

The Act which came into **effect on 1 January 2016 changes SADA's status**. Due to the need to increase its independence (based on the World Anti-Doping Code), it receives the status of a contributory organisation **established by law** as an independent organisation that carries out the tasks of prevention and control in the field of doping in the territory of the Slovak Republic. In line with the World Anti-Doping Organisation's rules, the personal scope of the Agency's authority is also amended.

In addition to the legislative regulation of its status, the Agency must meet certain qualitative parameters for its activities. These are based on the organisational structure of the organisation, i.e. the organisational, working and registry regulations and plan. In the area of doping control processes and the granting of therapeutic use exemptions, **SADA** is governed by a quality certificate according to the standard STN EN ISO 9001:2015.

The main objective of SADA is to carry out the tasks **set out in the Sports Act**. It is primarily the implementation of preventive measures in the fight against doping in sport on the basis of cooperation with WADA and international anti-doping organisations. Cooperation with international sports federations and national sports associations is important, especially in the coordination and **direct carrying out doping control in sport, mainly at the top and performance level**. This irreplaceable mission also results from the adoption and application of international treaties and conventions to which the Slovak Republic is a signatory, an important part of SADA's mission is the ongoing provision of education for selected target groups of athletes and overall educational activities in this area.

III. SADA'S ACTIVITIES IN 2023 - ASSESSMENT

SADA's tasks are defined in its basic documents and in the Contract entered into between the Ministry of Education, Science, Research and Sport of the Slovak Republic and SADA for 2023.

I. OVERVIEW OF DOPING CONTROLS CARRIED OUT

In 2023, SADA carried out doping controls in line with the concluded Contract and the World Anti-Doping Code. In line with the TDSSA standard, additional analyses are performed at least at a minimum quantity based on a breakdown by sport and sport discipline. the main objective in 2023 was to maintain the proportion of out-of-competition testing at two-thirds of the total number of collections compared to in-competition testing. the 2023 testing focused on targeted out-of-competition testing of athletes in at-risk sports with potential participation in the 2024 Paris Olympics. .

SADA carried out a total of 443 doping controls in 2023, of which 307 were at the initiative of SADA and 136 at the initiative of an international sports federation.


URINE SAMPLE COLLECTIONS INITIATED BY SADA

In 2023, SADA carried out 307 urine sample collections at its own initiative. Additional 136 urine sample collections were carried out in cooperation with national and international sports associations, making a total of 443 urine sample collections. Compared to 2022, SADA performed 15 % less urine sample collections at its own initiative, which is in line with the distribution testing plan. the number of urine sample collections ordered increased by 45 %, which is mainly due to the fact that in 2022 SADA performed a large number of sample collections at the European Youth Games in Banská Bystrica, whereas in 2023 there was no such large event on the territory of the Slovak Republic.






TOTAL NUMBER OF CONTROLS




Urine sample collections performed at the initiative of SADA may be divided into in-competition and out-of-competition sample collections. SADA continues the trend of increasing the ratio of out-of-competition to in-competition testing. In 2023, SADA set a 2:1 ratio of out-of-competition to in-competition collections in the distribution testing plan, which we were able to meet after conducting 202 out-of-competition urine collections (66%) and 105 in-competition urine collections (34%).









SADA carried out a total of 307 urine sample collections in 2023, of which 202 were out-of-competition collections and 105 were in-competition collections.



In 2015 the TDSSA Technical Document came into force, which is revised annually and according to which additional analyses for ESAs (erythropoiesis-stimulating agents), growth hormone from blood and its factors from urine (GHRFs) need to be performed. an additional "SPC" (steroid profile confirmation) analysis had to be performed upon request from the laboratory if the sample showed non-standard steroid profile. So far, however, only one confirmatory steroid profile analysis has revealed the presence of a prohibited substance. SADA is responsible for meeting this standard only for doping controls for which SADA is the delegating organisation, on the basis of which at least a minimum number of additional analyses have been achieved from the perspective of individual sports and disciplines.

In 2023, SADA performed 83 ESA analyses, 62 GHRFs analyses and 9 additional SPC analyses.



BLOOD DRAWS

In recent years, SADA has successfully introduced the performance of blood draws and established the background for the gradual profiling of the haematology module of the Athlete Biological Passport (ABP). In 2023, SADA performed 74 blood draws for ABP and 5 blood draws for growth hormone (GH) analysis. Compared to 2022, the number of ABP blood draws has increased by 24, mainly due to an increase in the number of ABP blood draws of individual athletes.



ANTI-DOPING RULE VIOLATIONS

Seven cases of possible anti-doping rule violations were recorded.

In 2023, SADA recorded 7 cases of possible anti-doping rule violations. Of these, 6 cases were analytical (prohibited substance(s) found in an athlete's biological sample) and 1 was non-analytical (the result of a doping investigation). As at 31 December 2023, 5 out of 7 cases have been closed with the issuance of an anti-doping rule violation/non-violation decision. Four cases were concluded with a SADA decision and 1 case with a decision of the Commission for Doping Proceedings of the second degree. the remaining 2 cases are still in the procedural phase.

- **1.** the first closed case was reported in fitness where the prohibited substance dehydrochloromethyltestosterone was identified in a female athlete's urine sample.
- **2.** the second closed case was reported in fitness, where the prohibited substances amiloride and chlorthalidone were identified in a female athlete's urine sample.





- **3.** the third closed case was reported in power triathlon where the prohibited substances testosterone or testosterone prohormones and 5-methylhexane-2-amine were identified in an athlete's urine sample.
- **4.** the fourth closed case was recorded in floorball, where an athlete was identified with a non-analytical anti-doping rule violation, namely the use and possession of the prohibited substance ostarine.
- **5.** the fifth closed case was recorded in power triathlon, where the Commission for Doping Proceedings of the first degree terminated proceedings for a possible anti-doping rule violation without sanctioning the athlete. SADA subsequently filed an appeal against this decision, which was dismissed by the Commission for Doping Proceedings of the second degree.

II. ADAMS

ADAMS (Anti-Doping Administration and Management System) is an internet database system developed by the World Anti-Doping Agency. It enables entering, storing, sharing and providing information about individual athletes and their places of stay, doping controls, therapeutic use exemptions (TUEs) and possible sanctions against athletes.


In the fourth quarter of 2017, new criteria for inclusion of athletes in the National Registered Testing Pool and the ADAMS system were created. Based on these criteria for inclusion of athletes in the National Registered Testing Pool and the ADAMS system and based on the selection of athletes according to risk factors, the Agency was gradually reducing the number of athletes included. the reduction in the number of athletes was made on the basis of recommendations from WADA. Each athlete included in the register must have a minimum of three sample collections per year, which has logically resulted in a reduction in the number of athletes.

ADAMS STATISTICAL DATA

The Agency is continuously updating the Registered Testing Pool, which includes at the end of 2023 a total of 80 athletes. 21 national team members are included in the National Registered Testing Pool (NRTP), 43 athletes in the Basic Register (BR) and 16 national team members in the International Registered Testing Pool (IRTP).

Athletes from 18 national sports associations are included in the testing pool, where summer Olympic sports are made up of 13 sports associations, winter Olympic sports are made up of 3 sports, and two sports associations are non-Olympic.









WARNINGS AND UNAVAILABILITY FOR TESTING

In 2023, SADA issued 25 warnings for the failure to file data in the ADAMS system and unavailability for testing.



Due to the gradual decrease in the number of athletes in the National Registered Testing Pool, the number of warnings issued for failure to provide required information on change of residence / unavailability for testing decreased. With fewer athletes in the NRTP, SADA could conduct more out-of-competition controls per athlete (at least 3 doping controls per year).



Three warnings were issued for unavailability for testing and were assessed as anti-doping rule violations.





Three athletes were issued the first warning out of a total of three possible anti-doping rule violations. Two athletes were issued two warnings out of possible three warnings. the Agency requested a written explanation of the violation of the aforementioned rule and the subsequent reconciliation of the sports training schedule (monitoring form of stays in the online system ADAMS) and its notification so that any further out-of-competition doping control could be carried out without delays and without consequences for the sporting activity.

III. THERAPEUTIC USE EXEMPTIONS


CONSULTANCY

The aim of the consultation activity is to provide athletes with a space for questions and answers, especially in relation to information about prohibited substances or their presence in certain medicines or nutritional supplements. In 2023, the Slovak Anti-Doping Agency provided 128 expert consultations on medicines and nutritional supplements.

In 2023, the Medicines Database Project (www.zakazanelatky.sk) continued, through which athletes can look up a medicine and verify the presence of a prohibited substance.

When it comes to questions concerning the composition of medicines and their safety in terms of doping effect, the assessment of the presence of a prohibited substance is very precise, as medicines are subject to strict regulation and the information about the composition of medicines is clearly defined. Most of the medicines consulted did not contain any prohibited substance, in some cases we recommended a change of medication. the most frequent were drugs from the group of antihistamines, antibiotics, glucocorticoids, analgesics and dermatologics.

OVERVIEW OF GROUPS OF MEDICINES SENT FOR CONSULTATION BY ATHLETES



IV. EDUCATION

Education and prevention are at the heart of protecting clean sport, which is why we try to use different forms of educational activities. the main pillar of our anti-doping programme is the ADeL online education platform, which is free and accessible for anyone. We also regularly conduct personalized lectures based on the client's requirements. Last but not least, we publish articles, expert materials, podcasts and use social media to raise awareness of anti-doping issues.

In 2023, SADA staff delivered 73 lectures. Of the total number, 64 lectures were face-to-face and 9 took place online. the target group was athletes and support staff of individual sports federations, primary and secondary school and university students, as well as members of the doping proceedings commission, doping commissioners and sports physicians. Within these lectures, not only the fight against doping in sport, but also the values of clean sport, awareness of nutritional supplements, prohibited substances and doping control were presented in an interactive way. Compared to 2022, we delivered 33 more lectures.





NUMBERS OF SESSIONS







V. EVALUATION OF THE ANNUAL DOPING CONTROL PLAN OF THE PREVIOUS YEAR

In 2023, SADA planned to conduct 300 doping controls under the Distribution Testing Plan in accordance with the World Anti-Doping Code, the International Standard for Testing and the TDSSA Technical Standard. In addition, SADA has been fully cooperative in the field of national and international cooperation, which includes in particular the preparation of doping controls and the performance of sample collections at sporting events of European and world importance. However, international cooperation in doping controls does not only include the cooperation of SADA in sampling in the Slovak Republic, but also the ordering of testing of Slovak athletes in a foreign country by the relevant anti-doping organisation.

Under the authority of SADA, the following collections were performed in 2023:

307 urine samples (105 in-competition and 202 out-of-competition) for which 83 additional analyses for EPO (ESAs) and 62 analyses for growth hormone factors (GHRFs) were ordered,

9 urine samples required additional analysis to confirm the steroid profile (SPC),

79 blood samples (5 for growth hormone detection and 74 for establishment and maintenance of blood passports),

Under other authority, SADA made the following collections in 2023:

136 urine samples;28 blood samples.

A total of 127 missions were required to carry out all collections in 2023. the shortest missions were completed in one day, the longest one lasted up to 5 days, collecting between 1 and 145 samples per mission.

In 2023, SADA recorded 7 cases of possible anti-doping rule violations. Of these, 6 cases were analytical (prohibited substance(s) found in an athlete's biological sample) and 1 was non-analytical (the result of a doping investigation). On 31 December 2023, 5 out of 7 cases have been closed with the issuance of an anti-doping rule violation/non-violation decision. Four cases were concluded with a SADA decision and 1 case with a decision of the Commission for Doping Proceedings at Level 2. the remaining 2 cases are still in the procedural phase.



REVENUE FROM THE STATE BUDGET




Revenue with source code 111 has been increased by an amount of 2 budget measures, EUR 26,000 for a cybersecurity project and audit and EUR 25,000 for DC analysis and training. Revenue with source code 111 was implemented for a total amount of EUR 580,423, representing 110 % of the authorised funds for 2023 of EUR 529,423.






REVENUE FROM OTHER SOURCE 46 IN 2021 - 2023









EXPENDITURE FROM THE STATE BUDGET IN 2021 - 2023



EXPANDITURE FROM OTHER SOURCE 46 IN 2021 - 2023




